## **PRE-SOLICITATION FOR TREATMENT SERVICES**

Deadline for Letter of Interest is 5:00pm CST on Monday, April 22, 2019

Imperial Calcasieu Human Services Authority (ImCal HSA) will be soliciting treatment services for a low barrier, up to 46-bed inpatient drug and alcohol rehabilitation facility to include a transitional living component for persons seeking substance disorder treatment services throughout the State of Louisiana, through the issuance of a contractual agreement for the period of three years beginning July 1, 2019 through June 30, 2022. Providers will be required to demonstrate their ability to house their services in Lake Charles, Louisiana utilizing an existing State-owned building.

Interested treatment providers must respond timely to the solicitation deadline and clearly show that (1) they can provide said services, (2) such services will be provided by certified, licensed professionals with experience in such treatment, (3) be willing to credential with Healthy Louisiana Managed Care Organizations, and (4) be willing to maintain a minimal number of indigent beds, reimbursable by ImCal HSA.
