Summary: Annual virtual conference for behavioral health providers.

The National Association on Dual Diagnosis is again having their annual conference virtually on **December 7-9, 2022**. The cost will be much lower than would be typical to attend a conference and hear from people doing work around the country and the world to improve outcomes for individuals with Intellectual and Developmental Disabilities (IDD) and Behavioral Health (BH) needs.
