Subject: Performance Improvement Project - Addressing Congenital Syphilis through Improved Syphilis Screening for Pregnant Enrollees

Summary: The statewide congenital syphilis rate in Louisiana has increased from 29.1 per 100,000 live births in 2011 to 106.9 per 100,000 live births in 2022.

Effective prevention and detection of congenital syphilis depend on identifying syphilis among pregnant women; therefore, routine serologic screening of pregnant women is required during the first prenatal visit at 28 weeks' gestation, and an additional time at delivery.

In 2021, Louisiana had the third highest case rate in the nation with 110 congenital syphilis (CS) cases an increase of 75% compared to 2020; 65% of cases occurred among black women, and 64% of mothers were under the age of 30 at delivery. During this same time, all nine of Louisiana's public health regions reported CS cases involving pregnant women and their babies. The most missed care opportunity among mothers linked to 2021 CS cases was the lack of timely syphilis retesting within the third trimester (44%).
