• Dan Trolaro is an excellent, engaging presenter who will educate attendees on the many facets of problem gambling for clinicians to be better able to recognize, screen for, and refer to treatment as indicated.

- Problem gambling is linked to many individuals, public health, and social problems including: depression, suicide, significant debt, bankruptcy, family conflict, domestic violence, neglect and maltreatment of children and criminal offenses. As with any addiction, treatment and early intervention utilizing various approaches can be very effective. This workshop will provide an overview and analysis of gaming and gambling, identifying vulnerabilities as well as the behavioral, emotional and psychological warning signs. Considerations for recovery will be addressed including screening, treatment and key principles and barriers faced by those who struggle with addiction as well as loved ones.

Harm reduction with the goal of improving retention in treatment will also be covered.
