Subject: CBP/BPD and GSD Provider Incentive for Quarter 4

Summary: AmeriHealth Caritas Louisiana is offering a provider incentive for submission of CPT Category II codes associated with complete blood pressure or blood sugar control result data during the 4th quarter.

Quarter 4 Incentive Program Details:

- 1. CBP/BPD: **\$25** per eligible member screened for whom a complete BP result taken between **10/1/2025 12/31/2025** is submitted via CPT CAT II codes.
 - Controlling Blood Pressure (CBP): adults 18–85 years of age with a diagnosis of hypertension, whose blood pressure (BP) is adequately controlled (<140/90 mm Hg) in the measurement year.
 - Blood Pressure Control for Patients with Diabetes (BPD): adults 18–75 years of age
 with diabetes (type 1 or type 2) whose BP is adequately controlled (<140/90 mm Hg)
 in the measurement year.
 - For CBP/BPD measures, the most recent (last BP of the year) is used. If multiple BP readings are noted in the chart on the same date, the lowest systolic and lowest diastolic BP results are used.
- 2. GSD: **\$25** per eligible member screened for whom a complete HbA1c result completed between **10/1/2025 12/31/2025** is submitted via CPT CAT II code.
 - Glycemic Status Assessment for Patients with Diabetes (GSD): adults 18–75 years of age with diabetes (type 1 or type 2) whose most recent hemoglobin A1c (HbA1c) or glucose management indicator (GMI) was at the following levels in the measurement year:
 - Glycemic Status <8.0%
 - Glycemic Status >9%
- 3. Incentive payments will be based on receipt of a claim for a qualifying service and paid through a CAP payment.

How do I participate?

- Identify eligible members within the CBP, BPD, or GSD measure. You may find useful reports with this information in Navinet.
- Document screening results and member information in the health record.
- Submit a claim with appropriate CPT CAT II codes.

CPT CAT II Code	Description	Age Limit
3044F*	Most recent HbA1c level less than 7.0%	18 and over
3046F*	Most recent HbA1c level greater than 9.0%	18 and over
3051F*	Most recent HbA1c level between 7.0% and less than 8.0%	18 and over
3052F*	Most recent HbA1c level between 8.0% and less than 9.0%	18 and over
3074F	Most recent systolic blood pressure <130 mm Hg	18 and over
3075F	Most recent systolic blood pressure 130 – 139 mm Hg	18 and over
3077F	Most recent systolic blood pressure >=140 mm Hg	18 and over
3078F	Most recent diastolic blood pressure <80 mm Hg	18 and over
3079F	Most recent diastolic blood pressure 80- 89 mm Hg	18 and over
3080F	Most recent diastolic blood pressure>=90 mm Hg	18 and over
