Why focus on reducing readmissions?

- Improves member well-being, as frequent readmissions can drain members and their families emotionally.¹
- Improves confidence in the healthcare system, as multiple readmissions can make members question the quality of care received on initial inpatient stay.¹
- Reduces overall cost of care, as readmissions can strain healthcare resources, such as number of hospital beds available, staffing and medical supplies. ¹

Measure Guidelines:

• The number of acute inpatient and observation stays during the measurement year that were followed by an unplanned acute readmission for any diagnosis within 30 days and the predicted probability of an acute readmission for our members aged 18-64.

How can you help?

- Utilize ADT alerts in NaviNet to identify members who had an inpatient hospital stay. For more information on how to access and use ADT alerts, review the <u>ADT Alert User Guide</u> found on our AmeriHealth Caritas Louisiana Provider website.
- Reach out to members to schedule their follow up appointment.
- Discuss discharge instructions, including medication changes, to ensure member understands their health condition.
- Address Social Determinants of Health, including transportation, housing and food insecurities.
- AmeriHealth Caritas' Case Management program offers Transition of Care (TOC)
 assistance to all members being discharged in efforts to improve their health and decrease
 readmissions. You can assist us in re-enforcing TOC efforts and member follow-up. You
