Subject: 2020 Healthcare Common Procedure Coding System (HCPCS) and Current Procedural Terminology (CPT) Codes

Summary: Important information regarding HCPCS and CPT code updates for 2020.

AmeriHealth Caritas Louisiana has updated its procedure code file to comply with the Louisiana Department of Health's (LDH) Health Plan Advisory (HPA) 19-18. In addition, prior to LDH publishing the updated fee schedule on lamedicaid.com, AmeriHealth Caritas Louisiana is in the process of updating its system with the 2020 HCPCS/CPT additions, changes, and deletions. The intent is to minimize denied claims due to a delay in the updated fee schedule being published. **Please note codes will receive denial code Z98 "Not covered by Medicaid" until the updated fee schedule has been published.**

- <u>Deleted codes will be termed effective January 1, 2020</u> Your remit will display denial code Z98 "Not covered by Medicaid." Claims submitted with deleted codes should be resubmitted with the appropriate procedure code.
- <u>New codes that are not currently identified on the 2020 fee schedule by LDH</u> these codes will receive denial code Z98 "Not covered by Medicaid" until LDH publishes a rate. Upon receipt of the updated LDH fee schedule, these claims will be automatically reprocessed. There is no action required by providers.
- <u>Claims denied due to the use of the new 2020 HCPCS/CPT codes</u> not on file as of January 1, 2020, will be reprocessed once the fee schedule updates are complete.

What do you need to do?

Providers should submit claims for the appropriate HCPCS/CPT code to preserve timely filing. Once LDH has provided these rates, AmeriHealth Caritas Louisiana will update the system and reprocess all denied claims affected by these updates.
