## Subject: National Immunization Awareness Month (NIAM)

**Summary:** During NIAM, AmeriHealth Caritas Louisiana (ACLA) encourages you to ensure your patients are up to date on recommended vaccines. Research has consistently shown that healthcare professionals are the most trusted source of vaccine information for parents and patients. We would also like to make you aware of a free online course regarding the importance of HPV Vaccination.

August is National Immunization Awareness Month (NIAM). This annual observance highlights the efforts of ACLA Healthcare professionals to protect patients of all ages against vaccine-preventable diseases through on-time vaccinations.

We encourage our healthcare professionals to use NIAM as an opportunity to access <u>CDC educational</u> <u>resources</u> like the <u>#HowIRecommend Video Series</u>, which offers simple and practical guidance for having successful vaccine conversations with parents and patients. These short videos demonstrate how to make effective vaccine recommendations, address common vaccine questions, and take a team-based approach to vaccination.

Show your practice's support of vaccinations throughout the month by using this content on your website and on social media. During NIAM and beyond, you can engage with CDC and other healthcare professionals on social media by using #ivax2protect in your posts.

As a reminder, PCPs are expected to complete required immunizations for children ages birth through 20 during well-child visits. In order to comply with this policy, PCPs should enroll in the Louisiana Vaccines for Children (VFC) program to receive vaccines without charge for Medicaid children ages birth through 18. To enroll, contact the Immunization Program Office at 504-838-5300.

**\*Please Note**: Louisiana Medicaid also considers beneficiaries ages 19 and 20 part of the EPSDT population and therefore age-appropriate immunizations are required, although outside of VFC.

Immunizations are also required for reporting The Healthcare Effectiveness Data and Information Set (HEDIS) to the National Committee of Quality Assurance (NCQA). The focused measures for HEDIS MY2021 include Childhood Immunizations (CIS), Immunizations for Adolescents (IMA), and Lead Screening in Children (LSC).
