# Subject: Changes to our Quality Enhancement Program (QEP) Incentive Program

**Summary:** AmeriHealth Caritas Louisiana has made changes to the Primary Care Provider Quality Enhancement Program (QEP), a value-based compensation program for participating primary care providers (PCPs). Changes include realignment of quality measures to meet Louisiana Department of Health's (LDH) requirements, Member Experience Pulse Survey scoring, and addition of an incentive for COVID Vaccines. Modifications to the QEP are detailed in this document, as well as the updated QEP manual.

The program includes a COVID Vaccine Series Completion measure. Incentive payment is based upon the volume of attributed members who have received the completed COVID vaccine series. Primary Care Practices eligible to participate in the QEP and whose rate is ranked in the top 50<sup>th</sup> percentile will be eligible for an incentive under this metric. A fixed funding pool will be distributed across these eligible providers on a sliding scale whereby the highest performing providers receive a larger share of the available pool.
